前言 Introduction	中國香港體適能總會作為推動健康體適能的先鋒，多年來一直參與服務社區的工作。近年社會各階層對健康體適能的關注日漸增加，社區體適能的推廣及教育因此而有增無減，為配合本會未來於社區服務方面的發展，務求令社區服務團隊更完善及專業化，並提升服務質素。本會現招募 2027 至 2029 年度「社區體適能活動統籌」，擔當協調及管理的角色，任期為兩年。 As a pioneer in promoting health and physical fitness, the Physical Fitness Association of Hong Kong, China (HKPFA) has been actively serving the community for many years. In recent years, public concern for health and fitness across all social strata has been steadily increasing, leading to a growing demand for community fitness promotion and education. To align with our future development in community services, enhance team structure, promote professionalization, and elevate service quality, the Association is now recruiting "PFA Coordinators" for 2027–2029. Coordinators will play a key coordination and management role for a two-year term.

申請資格 Eligibility Criteria	如欲申請成為「社區體適能活動統籌」必須符合以下條件： 1. 必須為本會會員； 2. 必須持有有效高級體適能測試領袖證書 / 私人體適能教練證書，或其他同等的學歷 / 專業資格； 3. 具有 5 年或以上參與本會社區服務經驗及服務時數達至少 300 小時；

	4. 具备良好的溝通技巧、領導才能及團體合作精神； 5. 通過性罪行定罪紀錄查核； 6. 通過遴選及面試。 To apply to become a "PFA Coordinator", applicants must meet the following requirements: 1. Must be a valid member of the Association; 2. Must hold a valid Advanced Physical Fitness Test Leader Certificate / Personal Fitness Trainer Certificate, or equivalent academic/professional qualifications; 3. Possess at least 5 years of experience in the Association's community services with a cumulative total of at least 300 service hours; 4. Possess excellent communication skills, leadership ability, and team spirit; 5. Must pass the Sexual Conviction Record Check (SCRC); 6. Must pass the selection process and interview.
申請方法 Application Method	申請者請於截止日期前填妥網上申請表格，本會將收集到的申請資料作初步遴選。 Applicants should complete and submit the online application form before the deadline. Collected application details will be submitted for preliminary screening.
截止日期 Application Deadline	2026 年 11 月 30 日 (逾期報名及資料不全者，將不作考慮)。 30 November 2026 (Late submissions or incomplete applications will not be considered).
申請結果 Application Results	於 2027 年 1 月於本會網頁上公佈社區體適能活動統籌。 The list of appointed PFA Coordinators will be announced on the Association's website in January 2027.

Shortlisted candidates will be contacted by phone for an interview on or before 30 November 2026. 2. Applicants who previously applied to be PFA Coordinators are required to re-apply. Applicants must be valid members of the Association, hold valid professional fitness qualifications, and pass the Sexual Conviction Record Check to be eligible for service.
